Contracts/Purchase Orders Postings Search

Pennsylvania's Judicial Code and County Code require the counties to furnish certain accommodations, goods and services for the functioning of the courts, provide staff for the courts, and pay the salaries, fees and expenses of judicial officers as well as system and related personnel. It is important for those seeking contract and order information of some judicial districts to recognize that those documents are solely executed by the executive branch of county government, and therefore, such do not appear on this Web site. Contract/Purchase Order Search Results









Once a search is performed, there are a few important differences within your results. First, viewing the details of a posting was previously completed by clicking on the **Posting Number**. Beginning on May 9, this selection is made by clicking the Document Posting Details icon  appearing to the right of the posting.

Similarly, for amendment postings only, you could previously view the details of a parent contract posting by clicking on the posting's **Parent Contract** number. On May 9, this same action is performed by clicking on the Parent Contract Document Posting Details icon .

What's changed on the Financial Records screen?

In addition, the process for printing your search results has changed. Prior to May 9, individual postings could be selected prior to clicking the *Print Selected* link. Beginning on May 9, postings may be selected as usual, but the Print Selected option has been moved beneath the Three Lines menu button , above the grid, at the far-right of the screen. This menu also contains the option to print all of your search results.

Judicial Expenditure Search Results

Previously, the *Detail* link appeared in the search results grid for each of the expenditures shown. This link opened a separate screen that showed all the information in the search results for the corresponding expenditure plus the address of the payee.

Beginning today, the payee's address now appears in the search results grid. As a result, the *Detail* link has been removed since the grid displays all available information.

In addition, the process for printing results has changed in the same way as Contract/Purchase Order search results. Refer to pg. 3 for more information.
