

Statewide Warrants



➤ What is the Statewide Warrants Function?

The Statewide Warrants function provides access to warrants generated from the Common Pleas Criminal Court Case Management System (CPCMS) and the Magisterial District Judge Management System (MDJS). Information pertaining to active warrants is available regardless of the date on which the warrant was issued. Information pertaining to inactive warrants is available for warrants issued within the last year.

1. Access the UJS Web Portal

In the address bar of your internet browser, enter <https://ujsportal.pacourts.us> and press the [Enter] key.



2. Click the Login link

3. Log into the Portal

Enter your user name and password and click the LOGIN button.

4. Access the Statewide Warrants screen

Hover your mouse pointer over *My Services* → *Law Enforcement* and click on *Statewide Warrants*.



Tip Depending on your access in the UJS Web Portal, the *Statewide Warrants* option in the menu may appear when hovering over *My Services* without an additional submenu.
